# 2024 RIDETECH LATE MODEL TRUCK SUSPENSION SYSTEM SWEEPSTAKES OFFICIAL RULES

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER THE SWEEPSTAKES OR TO WIN THE PRIZE. PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED BY LAW. # 2. ENTRANT ELIGIBILITY

This certificate will be equivalent in value to the highest-value product included in the Sweepstakes (\$3,540,0067), which can be used for the purchase of any other Ridetech product. Approximate retail value ("ARV") of the Sweepstake Prize is: Three Thousand Five Hundred Forty Dollars (\$3,540.00). Prizes are non-transferable and no cash redemption or prize substitution is allowed, except at Sponsor's sole discretion or as provided herein. Sponsor reserves the right to substitute any or all Sweepstakes Prizes, or a portion thereof, for another item of equal or greater value. Sweepstakes Prizes are nontransferable and non-assignable. Sweepstakes Prizes will be awarded only if the potential Sweepstakes Prize winner fully complies with these Official Rules.
